Both services include the document work we accept through the judgment stage. That is the paperwork for the court's final decision. The main differences are the detail involved and the rounds of draft changes.

Having children or an existing case does not, by itself, mean you need Complete. We review the work you request. You choose your legal options; we explain our service scope.

## What your payment covers

The price covers the service work we accept. Court fees and third-party costs are separate unless your signed records include them.

Paying in full at enrollment includes the discount shown. The monthly plan covers the same service as paying in full. A credit card on file is required for the monthly plan, with payments 2 and 3 charged automatically on the dates in your signed schedule.

Your full account balance must be paid before judgment work begins. Extra draft changes or other work outside scope require your separate authorization.

# What each service includes

## Super Fast Divorce®

For straightforward divorce or legal separation papers based on facts and terms you have already decided.

- Requested papers prepared from your facts and written directions.
- Included filing and standard service coordination.
- Included judgment papers and help with case closeout.

### **One combined round of draft changes.**

This service does not cover support orders or calculations, detailed parenting plans, real estate, retirement division, businesses, complex investments, digital assets, or missing-spouse and publication work.

## Complete Divorce™

For more detailed divorce or legal separation papers, such as parenting, support, property, or debt terms you have already decided.

- Broader document work within the scope we accept.
- Included filing and standard service coordination.
- Included judgment papers and help with case closeout.

### **Up to three combined rounds of draft changes.**

Legal advice, negotiation, mediation, and court representation are not included. Property valuation, tax advice, and retirement-plan division orders are also outside this service.

## What is a round of draft changes

You send your changes together so we can make them in one pass. Super Fast includes one round. Complete includes up to three. Changes must stay within the accepted scope.

## Do both services include the final papers

Yes, within the scope we accept. Both include judgment papers and case closeout work. Your full account balance must be paid before judgment work begins. The court decides whether to accept the papers.

## Already filed
